businesses re-open their doors. Our CDFI provided Paycheck Protection Program funding, lines of credit and other term debt products to fund hiring, inventory and equipment. Meda's Minnesota MBDA Business Center and Ascend Twin Cities connected BIPOC contractors to secure contracts that lead to sustainable growth.

In all, Meda served 702 BIPOC Entrepreneurs, helping them secure \$24.1 million in finance and winning \$50.3 million in contracts. These results led to the creation or maintenance of 1,632 jobs in these businesses.

The Director of Finance and Administration provides the Personnel Committee with a salary range comprised from comparatives of similar nonprofits. The Personnel Committee recommends a compensation adjustment for approval by the board.

Meda uses a similar process for other officers and all employees. Each individual undergoes an annual performance review with their supervisor. Supervisors award merit adjustments from a merit pool identified in the approved operational budget.
